The ITSS Standard-Specification – Interface 1 defines an ITSS Manufacturer ID, which is used as a prefix for other IDs within the standard to uniquely identify telematics devices and transport devices. This document lists all officially approved ITSS Manufacturer IDs and describes the process by which 3rd parties may apply for their own ITSS Manufacturer ID.

## 1. Construction of the ITSS Manufacturer ID for Interface 1

The ITSS Manufacturer ID consists of exactly 5 digits of printable ASCII codes from '0' to '9' and from 'A' to 'Z'. Lower case letters or special characters are not allowed. The ITSS Manufacturer ID must be unique, so a once assigned ITSS Manufacturer ID can never be assigned a second time.

At last you must follow the above mentioned construction rules. It cannot be guaranteed that the proposed 5 letter code will be accepted.

Any application for an ITSS Manufacturer ID will be processed in the next ITSS practice group meeting. Newly assigned ITSS Manufacturer IDs will be added to the above stated list, which concludes the successful application process.
